understand and accept that the use of a kayak, standup paddle board or any other small boat use exposes me to many hazards and participating in the use and participating in events sponsored by Rowing and Paddling For All LLC DBA Little Harbor Boathouse (LHB) entails unavoidable risk of possible death, personal injury and loss of or damage to property. I also understand I should be in good physical health to participate in activities. I choose to participate in these events in spite of these risks and hereby assume all risk of injury or loss of life to myself and loss of or damage to property arising out of my participation. **WAIVER:** I hereby assume all risk of injury, illness, death and loss of or damage to my property arising out of my participation rowing and paddling from the LHB. Further, in consideration of LHB furnishing private rack storage, rowing shells or services to enable me to participate in on-the water activities, I specifically release and forever discharge LHB and it's officers, agents, employees (and other participants) of LHB from any and all liability or claims for any injury, illness, death or loss of or damage to property which I may suffer while participating in a rowing event. This release and discharge specifically includes, but is not limited to, liability or claims for injury, illness, death or damage caused by the negligence of LHB or its officers, agents, employees or participants of LHB.

In signing this document, I fully recognize that if injury, illness, death or damage occurs to me while I am engaged in any rowing event associated with the LHB, I will have no right to make a claim or file a lawsuit against LHB or its officers, agents, employees or participants of LHB, even if they or any of them negligently cause my injury, illness, death or damage caused by the negligence of LHB or its officers, agents, employees or participants of LHB. In signing this document, I fully recognize that if injury, illness, death or damage occurs to me while I am engaged in any event associated with LHB or it's assigns, I will have no right to make a claim or file a lawsuit against LHB or its officers, agents, employees or members of LHB, even if they or any of them negligently cause my injury, illness, death or damage.

I understand that I and anyone for whom I sign as a parent or Guardian must meet the minimum age eligibility requirements specifically: 5 years old to ride, all children under 8 must have 1 adult per child aboard.

I understand that I must at all times wear or have on my boat an approved US Coast Guard life vest of the appropriate size and the life vest must be the properly fastened at all times while in a rowing shell, kayak or standup paddleboard. I understand the LHB carries no medical insurance on participants. The laws of the Common wealth of Massachusetts shall govern the interpretation of this instrument.

I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND ITS CONTENTS. I AM AWARE THIS IS A WAIVER AND A RELEASE OF LIABILITY AND I SIGN IT VOLUNTARILY AS AN INSTRUMENT UNDER SEAL.
